**The Asphalt Pavement Hall of Fame was established to recognize and honor those individuals who have made significant and lasting contributions of regional and/or national importance to the asphalt pavement industry leading to innovations in the production and placement of asphalt pavements, the usage of asphalt as a paving material, and/or the general advancement and recognition of the industry.**

**The Asphalt Pavement Hall of Fame was established by the National Asphalt Pavement Association (NAPA), the national trade association representing the asphalt pavement industry, to recognize and honor those individuals who have made significant and lasting contributions of regional and/or national importance to the industry.**

### **WHO IS ELIGIBLE?**

Individuals who have been active in the asphalt pavement industry affiliated with asphalt production and placement firms or with manufacturers and suppliers of equipment and services to the industry.

Also eligible are individuals from public works agencies at the federal, state, and local levels, other governmental agencies interacting with the asphalt pavement industry, educators and researchers from educational/trade institutions, and consulting firms. The principal criteria for all nominees are that their contributions must have been of regional and/or national significance.

Posthumous nominations may also be made for deceased individuals from any of the above capacities, but must be nominated within five years of their decease.

### **NOMINATIONS**

Nominations can be made at any time by any individual for consideration by the Asphalt Pavement Hall of Fame Committee. To make a nomination, simply complete the official nomination form included here. An official Asphalt Pavement Hall of Fame nomination form must be filled out for each individual nominated and returned to the Hall of Fame Committee before an individual will be considered. The Hall of Fame Committee meets annually, at a time and place determined by the Chairman, to consider all applications submitted. Individuals approved by the Hall of Fame Committee will be notified (if living), as will the nominator of that individual.

### **INDUCTION**

A suitable time and place for induction ceremonies will be established as soon as possible for individuals elected to the Asphalt Pavement Hall of Fame. Those elected will be presented an appropriately inscribed medallion-plaque and a similar medallion-plaque will be placed on permanent display in the National Asphalt Pavement Association office.
