

## FHWA Releases FY17 Highway Obligation Authority

On May 24, the Federal Highway Administration issued a formal notice (<u>N4520.245</u>) distributing \$44.26 billion for the federal-aid highways program provided by the FY 2017 omnibus appropriations bill (Public Law 115-31). Even though the 2017 total amount is \$905 million higher than 2016, almost all states received less money in the initial redistribution than they did last year due to the late start in obligating funding in FY 2016 for the new FASTLANE (allocated) grant program. Fast Lane grant money not obligated by August will be redistributed to the states to be used before the end of the fiscal year.
