

Consolidated Appropriations Act Fully Funds 2023 Construction Season NAPA priorities included in new Public Law January 2023

Congress passed H.R. 2617, the *Consolidated Appropriations Act, 2023* paving the way for state and local transportation agencies to plan and budget for the 2023 construction season. On December 22 the U.S. Senate passed the legislation by <u>a vote of 68-29</u>. On December 23, the House of Representatives passed the legislation by <u>a vote of 225 to 201</u>, sending H.R. 2617 to the President's desk. On December 29, 2022, the President signed into law: <u>H.R. 2617, the Consolidated Appropriations Act, 2023</u>.

The Consolidated Appropriation Act includes all twelve appropriation bills that fund the federal government, including the Transportation, Housing and Urban Development, and Related

Agencies Fiscal Year 2023 Appropriations Bill (THUD). The bill is over 4,000 pages consisting of 35 divisions. Division L of the bill contains the THUD appropriations bill. Previous bill text, summaries, fact sheets and explanatory statements can be found here.

NAPA was successful in securing records amount of highway and airport infrastructure funding for the asphalt pavement industry; securing \$3 million for the <u>Airport Asphalt Pavement Technology Program</u>; securing language supporting Critical Commerce Corridors; and preventing any pavement type selection or pavement design mandates. Highway and Airport Funding

The bill provides the U.S. Department of Transportation with a record amount of budgetary resources totaling over \$106 billion to fund highways, transit, rail, aviation, and other surface transportation-related infrastructure projects and research. Specifically, the Consolidated Appropriations Act will continue to invest in highways, roads, bridges, and airports, consistent with the historic investments in the Infrastructure Investment and Jobs Act (IIJA).

The bill includes a total of \$62.9 billion (not counting IIJA's advanced appropriation of \$9.454 billion in FY 2023) for the Federal Highway Administration (FHWA), an increase of \$2.3 billion compared to fiscal year 2022. Of this total, \$58.765 billion is from the highway trust fund to meet the Infrastructure Investment and Jobs Act obligations for Federal-aid highway programs and \$3.418 billion from the general fund, which includes \$1.145 billion to reduce the backlog of structurally deficient bridges. *(Note: Federal highway funding in 1998 totaled just \$27 billion, or \$49 billion in today's dollars.)*

Padilla-Cornyn Legislation Added to Omnibus

Prior to voting on final passage of the bill, the Senate approved <u>an amendment</u> on voice vote that allows state, local, and tribal governments to use parts of their federal COVID aid allotment for a broader list of infrastructure projects including roads and bridges. <u>NAPA has pushed for passage of the legislation</u> since the summer of 2021.

Under the legislation, state and local governments receiving COVID relief funds can use up to 30 percent of their American Rescue Plan Act funds, or up to \$10 million, whichever is higher, on

Congressional Directives

The Appropriation Committee report accompanying the Consolidated Appropriations Bill, 2023 includes a number of directives instructing the U.S. Department of Transportation how a particular appropriation should be used. This can take the form of a general suggestion, warning, precise instructions, and even earmarks. Enacted congressional directives can be found in two documents: 1) <u>Division L – Explanatory Statement</u>, and 2) <u>House Report 117-402</u>.

Specifically, the joint explanatory statement accompanying Division L is approved and indicates congressional intent. Unless otherwise noted, the congressional directives in House Report 117-402 carries the same weight as language included in this joint explanatory statement and is to be complied with unless specifically addressed to the contrary in the joint explanatory statement.

Below are the congressional directives relevant to the asphalt pavement industry.

Pavement Related Congressional Directives from Division L

Local hiring

The agreement (Consolidated Appropriations Act, 2023) encourages the Department (of Transportation) to update its guidance on local hiring flexibility to allow local hiring preferences on projects funded by the Infrastructure Investment and Jobs Act [IIJA] to the extent permissible under section 25019 of Public Law 117-58.

Resiliency

The agreement directs the Department to expand its technical assistance and trainings to help state DOTs, local governments, and Tribal governments develop reliable indicators of vulnerability and actionable mitigation measures in all phases of transportation planning, asset management, project-specific planning and development, and operations toward improving resiliency and reducing lifecycle costs. The agreement also directs the Department to prioritize research and demonstrations of new and proven technologies that could make infrastructure systems more resilient and to share such technologies with other state and Federal partners as appropriate.

Concrete research

The agreement includes \$5,000,000 for an accredited research university of higher education, in partnership with a producer of steel in the United States, to conduct research on the properties of steel slag materials for use in cement and concrete, furthering previous research under the Federal Highway Administration's [FHWA] highway research and development.

Non-traditional emerging technologies council [NETT]

The agreement encourages <u>the NETT</u> to develop and establish Department-wide processes, solutions, and best practices for identifying and managing non-traditional and emerging transportation technologies and projects, and to provide assistance to local and state governments for non-traditional emerging technologies.



Airport technology

Of the amount for airport technology research, \$6,000,000 is for the airfield pavement technology program authorized under section 744 of Public Law 115-254, of which \$3,000,000 is for concrete pavement research and \$3,000,000 is for asphalt pavement research.

Resilient infrastructure

The agreement directs the FHWA to continue to prioritize research, development, deployment, and demonstrations of new and proven technologies that could make infrastructure systems more resilient.

Greenhouse gas (GHG) emissions

The agreement directs the Department (FHWA) to continue efforts to research, develop, promote, and deploy materials that will help reduce lifecycle GHG emissions.

Interstate projects in the intermountain west

The agreement encourages the FHWA to work with state DOTs and local governments to move forward on several projects in the intermountain west, including 1-10 improvements, 1-11 construction, 1-17 improvements, U.S. 95 expansion, the North-South corridor study in Pinal County, and completion of the Sonoran corridor.

Pavement Related Congressional Directives from House Report 117-402

Advanced Research Projects Agency—Infrastructure (ARPA-I)

The recommendation includes funding, as requested, to establish the <u>ARPA–I</u>, which was authorized in section 25012 of the Infrastructure Investment and Jobs Act (IIJA) (P.L. 117–58). Not less than 90 days after the date of enactment of this Act, the Department shall submit to the House and Senate Committees on Appropriations a staffing plan for ARPA–I and an outline of planned research activities.

ARPA–I is an opportunity to ensure that the U.S. is a global leader in developing and deploying advanced transportation infrastructure technologies and materials. In partnership with industry, state and local governments, and academia, ARPA–I can advance solutions that will, among other things, promote the safe and efficient movement of goods and people, reduce greenhouse gas emissions, and protect against physical and cyber threats. In addition, ARPA–I is authorized to support and accelerate transformational technological advances in areas in which the private sector is un-likely to carry out projects due to technical and financial uncertainty.

Immersive technology

The Committee encourages the Assistant Secretary for Research and Technology to consider the potential of immersive technology as a tool for remote collaboration and site inspection or preparation by engineers, architects, and construction workers with the objective of improving worker safety, avoiding system closures, and improving service.

Permeable pavements

The Committee continues to encourage the Secretary to accelerate research, demonstration, and deployment of permeable pavements to achieve flood mitigation, pollutant reduction, stormwater runoff reduction, environmental conservation, and resilience for new road construction and retrofit of existing roads. The Committee encourages the Secretary to conduct structural evaluations of flood-damaged pavements, with emphasis on local roads and highways subject to flooding and extended periods of inundation, to understand the mechanisms of flood damage and how permeable pavements might be used to prevent or reduce damage from future flooding. Furthermore, the Secretary is encouraged to work with the Federal Emergency Management Agency (FEMA) and the Environmental Protection Agency (EPA) as both agencies are also doing work in the area of permeable pavements and a cross-agency collaboration may yield more innovation. In House Report 117–99, the Committee directed the Department to submit a report detailing current efforts, utilization, and research within FHWA and efforts made with FEMA and EPA and the Committee looks forward to the forthcoming report.

Material neutrality

The Committee supports the FHWA's work to promote research, development, and deployment of building solutions that advance the performance, sustainability, reliability, and resiliency of building materials. The Committee encourages the Department to support material neutral decisions that do not promote or provide preference for specific building materials. The Committee believes that Federal resources are best utilized when all materials are considered on their own merits, allowing for the best solutions to address our infrastructure challenges.

Aggregates sustainability

Aggregates are essential to the construction of highways, bridges, tunnels, and all types of public works projects and sustainable access to these materials is crucial in reducing costs, congestion, and emissions. The Department is directed to continue working with U.S. Geological Survey and stakeholders to ensure information on the availability of aggregates meets the nation's infrastructure needs. The Committee reminds DOT of the requirement in the House Report 117–99 to provide a report to the House and Senate Committees on Appropriations on how it can best address the challenge of the lack of sustainable aggregates resources in communities across the nation. The Department is encouraged to work with relevant Federal agencies, as well as state, tribal, and local transportation and planning agencies to further these efforts.

Concrete production

The Committee understands that a bi-product of concrete production, which is a critical component in most transportation projects, are greenhouse gas emissions. Considering the significant investment in the nation's infrastructure through the IIJA, the Committee supports efforts to reduce emissions in concrete production. The Committee encourages the Department to prioritize concrete manufacturing practices to reduce greenhouse gas emissions in transportation projects.

Alabama highway improvements

The Committee is aware of the significance of challenges faced by the southeast region of Alabama along routes that are critical for regional tourism, emergency evacuations, and provide access to the U.S. Army Aviation Center of Excellence and Fort Rucker. Due to steep grades along the route and an increasing number of passenger vehicles and heavily loaded freight carriers, roads such as highway 167 regularly experience delayed traffic flows and an increased number of traffic-safety hazards. The Committee continues to encourage FHWA to work with state and local stakeholders to address safety improvements to alleviate delays and chokepoints to ensure a clear route for the transportation of goods and services and for major emergency evacuations.

Virginia highway capacity

The Committee recognizes the challenges faced on certain highways in the Commonwealth of Virginia, which are critical to the freight network along the east coast. Inter- state 81, for example, is a corridor in Virginia that is two lanes in each direction, and when one lane is blocked there is a significant reduction in capacity. Contributing factors to the long crash clearance times include: lack of capacity, the rolling terrain, lack of reliable detour routes, and the constrained configuration. Travel is anticipated to continue to increase on some of these routes, with truck traffic growing at a faster pace than passenger vehicle traffic. The Committee encourages FHWA to work with state and local stakeholders to address surface conditions and other improvements to alleviate incident-related delays and backups.



Critical commerce corridors

The Committee believes critical commerce corridors, an authorized use of funds in the nationally significant freight and highway projects program, can improve our economic efficiency, reduce travel times, and promote safe travel on our nation's roads and highways. These corridors include existing highways where a barrier physically separates lanes dedicated to heavy commercial trucks from lanes dedicated to passenger vehicles. The Committee encourages DOT to strongly consider applications for the creation of critical commerce corridors when awarding grants to individual states.

Resiliency for coastal roads and highways

Coastal roads and highways, which are the lifelines of many communities, are facing major challenges from the effects of climate change, particularly sea level rise and coastal erosion. As DOT makes investments in coastal areas, the Committee continues to urge the Department to emphasize resiliency and support for roads that are currently in crisis situations, ensuring that the most vulnerable roads are being modernized utilizing best practices, and that planning for future resilient roads take these realities into account.

Resilient building materials

The Committee encourages the Department to require the use of resilient building materials that will reduce carbon emissions and nonpoint source pollution, as appropriate, in all Federally funded highway projects.

Innovative technologies

The Committee urges FHWA to consider the feasibility of utilizing or deploying innovative technologies, including moveable barriers, that provide congestion relief, improve air quality, and decrease fuel consumption. Innovative technologies can also offer quick alternatives to costly road construction, result in safer roadways, and help eliminate crossover fatalities. The Committee encourages FHWA to consider such technologies as part of any project for which the Federal government provides grants.

Bike lanes for equitable, sustainable transportation

The addition of high-quality bike infrastructure, including trails and protected bike lanes, is proven to reduce traffic fatalities and open up opportunities for healthy and zero-carbon transportation. High quality bike infrastructure opens up access for low-income communities and encourages cycling among novice cyclists and families who may have a lower tolerance for risk. The Committee encourages FHWA to work with state and local agencies to support greater implementation of bike lanes throughout the nation.

Infrastructure monitoring demonstration project

The Committee is interested in new technology advancements to monitor and assess the lifespan, safety, and durability of infrastructure investments, and reminds FHWA of the requirement in House Report 117–99 to brief the House and Senate Committees on its research in this area.

Communities impacted by persistent flooding

The Committee directs DOT, through its Federal lands access program, to provide consideration for communities that are impacted by persistent flooding.

FY 2023 Apportionments

Federal-Aid Highway Program Terminology

Distributions of funds is FHWA notification to the states of the availability of federal funds. Once a distribution is announced, the funds usually remain available to the states to obligate for four years. The states do not receive the funds prior to undertaking work.

Apportionment is the distribution of funds among the states as prescribed by a statutory formula.

Allocation is an administrative distribution of funds (often for specific projects) under programs that do not have statutory distribution formulas.

Reimbursement occurs once a project is approved, the work is started, costs are incurred, and the state submits a voucher to FHWA. The reimbursable structure is designed to curb waste, fraud, and abuse.

Contract authority is a type of budget authority that is available for obligation even without an appropriation (although appropriators must eventually provide liquidating authority to pay the obligations).

Obligation of contract authority for a project by FHWA legally commits the federal government to reimburse the state for the federal share of a project. This can be done prior to an appropriation.

Limitation on obligations, known as ObLim or Oblimit, is used to control annual FHWA spending in place of an appropriation. The ObLim sets a limit on the total amount of contract authority that can be obligated in a single fiscal year. For practical purposes, the ObLim is analogous to an appropriation.
